COVID-19 VACCINATION INFORMATION & DATA UPDATE

The Barren River District Health Department has confirmed a total of 28,398 cases, 25,767 of which have recovered. We have 388 deaths reported from COVID-19. We stand in solidarity with those affected during these difficult times. See the breakdown of numbers by county below. Please note that a decrease in numbers is due to the county of residence or case status being corrected/updated from what was previously reported.
